## October 20, 2016 Sloan Council Meeting

- 1. Mayor Thorpe called the Council Meeting to order at 7:02PM
  - a. Roll Call: Iverson, Brekke, Redmond, Smith and Thorpe

Also present: Deputy Charles Hertz, Justin Mitchell, Chris Mitchell, Jesse Kirkendall, Dave Christensen, Don Jones (Maintenance), Deputy Clerk Jill Berg and City Clerk Dixie Iverson.

2. Deputy Hertz provided an up-to-date directed patrol report.

#### 3. Open Session:

- **a.** Citizens opportunity to address the Council: No one was present to address the Council other than those listed on the agenda.
- b. Dave Christensen was present to ask the Council to approve the property inspection contract between the City of Sloan and Absolute Inspection Services, LLC. After some discussion about recommendations from the City Attorney, the Council and Mr. Christensen decided to ask the City Attorney to change the language as he felt necessary and return it to the City Clerk to be placed on the November agenda. He also wanted a copy of the zoning ordinances and noticed that those ordinances hadn't been updated since 1980. He asked if the Council would be interested in updating the zoning ordinances based on the ones for Sgt Bluff as those were current. The Council said they thought it might be a good idea to update as the other code of Ordinances were updated in 2014. They would like to see a copy of Sgt Bluff's zoning Ordinances.
- c. Dale Smith was not present to discuss Walpole Covenant's language. However, Councilwomen Smith had notes from Dale about certain questions people had asked about. That being able to buy two lots and build in the middle, then selling off a portion of one of those two los to a neighboring lot owner and what happens to a lot that had been sold but the owner did not build in the two year time frame.
