- **a.** The Council revisited the discussion on wage increases. The amounts suggested at the May 18 meeting were revised. They then moved on to Resolution 2023-11 with the amended amounts.
- b. Larson made a motion and Redmond seconded to approve and adopt **RESOLUTION 2023-11...a Resolution** approving wage increases and establishing market adjustments for city employees as follows: Peg Copple-an increase of \$1.02 per hour for a new hourly wage of \$17.99, Candy Lloyd-an increase of \$1.15 per hour for a new hourly wage of \$20.24, David Meyers-an increase of \$1.63 per hour for a new hourly wage of \$21.98, Todd Wilson-a market adjustment of \$4,956.39 for a new annual salary of \$54,520.25, Dixie Iverson-a market adjustment of \$4,669.56 for a new annual salary of \$51,365.13.
